A weight coupon or signed document must be presented for proof and an additional witness also is required. Beards measuring more than 12 inches must have additional witnessing and the application must include a photograph showing measurement. Spurs measuring over 1.5 inches must have additional witnessing and applications must include photographs showing measurement. Please include a picture if your bird has multiple beards.
